- 1) The re-engagement will be offered purely on contract basis up to 21.02.2023 from the date of contract.

- 3) **Age Limit** : Maximum 65 years (Applicant of max.64 years may apply)
- 4) **Experience** : Work related to Survey, updation of land records, coordination with State Government agencies for forest / wild life clearances in projects where land acquisition is involved.
- 5) **Applicant work/retired from same area / district where vacancy exist.**
- 6) **Mode of Selection:** Suitability will be adjudged by nominated screening committee . The decision of selection committee / administration in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.

7) **Remuneration, Allowances and Leave:**

- (i) A fixed monthly amount shall be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract.
 - (ii) No increment, Dearness Allowance and HRA shall be allowed during the term of the contract.
 - (iii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, they may allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
 - (iv) Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.
- 8) The re-engaged retired employees has to sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.
- 9) The selected retired staff has to undergo medical examination for medical fitness of the appropriate category from the designated authorities.
- 10) Removed/Dismissed/Compulsorily Retired employees are not eligible for re-engagement.
- 11) The retired employees selected for re-engagement shall strictly abide by all the terms and conditions of the re-engagement scheme from time to time.
- 12) The re-engaged staff can be terminated/discontinue from service by giving 15 days notice without assigning any reason by the administration.
- 13) Each case will be seen on case to case basis as regards need and merits. The decision of committee will be final.
- 14) The integrity aspect will be checked before such re-engagement.
- 15) Any subsequent changes in the terms and conditions in the Notification as per extant rules will stand good. Western Railway / Construction Organization reserves the right to consider / incorporate any subsequent changes/modification/additions/cancellation in terms & conditions to selection under this Notification as and when applicable.

- 16) Western Railway / Construction reserves the right to reject the candidature of any applicant at any stage of the process of selection, if any irregularity / deficiency is notice in the application /service record.
- 17) For any Legal Dispute, the jurisdiction will be Central Administration Tribunal, Mumbai only.
